  - FIA Anti-Doping Regulations, with subsequent changes,
  - Regulations for Environmental Protection in Motor Sports of PZM,
  - Polish Road Traffic Act,
  - This Supplementary Regulations.
  - ASN technical regulations (only in relation to national class cars),
  - This Supplementary Regulations

#### 4.2 Entry procedure

Entries must be submitted in accordance with the FIA RRSR Art. 21 – Art. 23. See also FIA ISC Art. 3.8 – Art. 3.14

Polish Automobile and Motorcycle Federation (PZM) accepts an equivalence between National and International Licences issued by ASNs of Central European Zone (CEZ) for drivers and co-drivers. Competitors with licences issued by ASNs other than CEZ ASNs, must hold an international licence of the appropriate grade.

**4.2.1** The onus is on competitor to send entry form and obligatory attachments. Those who wish to take part in Valvoline Rally Małopolski must fill the electronic entry form before the closing date for entries. An electronic entry application must be confirmed by way of personal signature by the competitor by the latest at Administrative Checks. The entry form must be accompanied by a copy of the valid competitor's licence. A change of competitor is permitted up to the close of entries. Only the competitor entered in the event will be allowed to make this request. The Application must also include safety equipment card of driver and co-driver to pass at the Scrutineering.

**4.2.2** Competitors who have a license issued by PZM need to sign in to the Inside PZM system and the competitor, driver and co-driver must confirm participating in the Valvoline Rally Małopolski a. Then the competitor is obligated to complete his electronic application and attach a confirmation of the entry fee payment. After the approval, the entry form will be automatically send by e-mail to the Organizer and to the Competitor (to the indicated in entry for e-mail address).

**4.2.3** For competitors who have a license issued by ASN other than PZM on the website <u>www.rajdmalopolski.pl</u> (Competitors section) will be available a separate entry form with attachments.

4.2.5 An entry application (also made electronically) will be accepted only if accompanied by the total entry fees.

**4.2.6** During a filling out the electronic entry form and on website <u>www.rajdmalopolski.pl</u> the following attachments will be available:

• request for adjacent space in the Service Park (optional).



**4.2.7** Administrative Checks will be organised remotely when entry is received. When sending your online registration entry form, please remember also to attached or send to e-mail biuro@rajdmalopolski.pl the following documents:

- Payment confirmation of the entry fee (to ensure that payment is duly receipted prior to the close of entries),

• Photocopies of the Competitor, Driver and Co-Driver Competition licenses (does not apply to licenses issued by PZM),

- Photocopies of the Driver and Co-Driver driving licenses,

- Photocopies of the Driver and Co-Driver passports or identification cards,
- Photocopy of ASN authorisation for all foreign competitors and/or drivers,
- Photocopy of vehicle registration papers,
- Photocopy of vehicle insurance cover certificate,
- Photocopy of competitor declaration, that he has vehicle owner permission to use the vehicle during the rally.

The above procedure does not exempt from the obligation to appear for Administrative Checks at the scheduled time.

In case one of the above listed obligations is no fulfilled, the Organiser can reject the entry.

**4.2.8** The competitor who wishes to receive an invoice for the entry fee, fee for additional space in the Service Park or other fees must attach to the entry form a billing detail. In addition, the message accompanying the transfer must include the tax number for the invoice. If it is not available, it will not be possible to issue an invoice later. Only after meeting this condition competitor will receive an invoice during Administrative Checks.

**4.2.9** After closing date for entries the electronic entry form will be available only for editing of crewmembers and the vehicle, according to Art. 22.2 and Art. 22.4 of FIA Regional Rally Sporting Regulations. Editing will be possible through an update form, which would be send to the e-mail address indicated in entry form.

**4.2.10** By sending the Entry Form the competitor, driver and co-driver agree for processing their personal data for the purpose of the organization of the rally and publishing photos and results in media and on the websites: <u>www.pzm.pl</u> <u>www.rsmp.pl</u> and <u>www.rajdmalopolski.pl</u>. Competitor/driver/co-driver have the right to access, rectify abovementioned and request to stop processing their personal data. Requesting to stop processing personal data means that competitor resigns to participate in Valvoline Rally Małopolski.

The entry fee in 2nd term is 600 PLN higher compared to any entry fee presented in a table in the Art. 4.4.2 of these Supplementary Regulations. The date of payment realization (not a date of payment order) stated in the bank transfer will decide for an entry fee.

**4.4.3** For legal entrants (car entered by a competitor with a competitor/sponsorship licence), the entry fee is PLN 600 higher than each amount included in the table in Art. 4.4.2. these supplementary regulations.

**4.4.4** In the case of application to the RSMP classification of sponsor teams, an additional entry fee of PLN 600 per 1 team applies.

4.4.5 In case of Application to the RSMP classification of manufacturer teams of 600 PLN per 1 team applies.

At the competitor's request, depending on space availability, the organizer may grant additional space in the Service Park after paying an additional fee (priority will be given to competitors with a competitor/sponsorship license). The fee for additional space in the Service Park is:

- 25 PLN/m<sup>2</sup> private entrants,
- 35 PLN/m<sup>2</sup> Legal entrants with a player/sponsor license.

**4.4.7** At the competitor's request (the appropriate box is marked in the entry form), if possible, the organizer may sell an additional package of rally documents in accordance with the table in Art. 8.3.3 of the RSMP 2024 Regulations. The price of the additional package is PLN 250.

**4.4.8** Each competitor registered for the rally has the right to use the so-called reconnaissance car according to the principles set out in Art. 9.5 of these supplementary regulations. The intention to use a reconnaissance vehicle must be indicated in the application form. A fee of PLN 600 must be paid to the organizer's account by the closing date for applications

**4.4.9** The entry fee does not include an insurance covering the competitor's third party liability insurance.

The entry fee shall be fully refunded:

- to teams whose entry application is rejected
- if the event does not take place.

The organiser may partially refund entry fees (up to 50%), if a competitor cannot take part in the event due to a duly proved case of force majeure (duly certified by their ASN). The application for a refund, stating the reason for not starting, must reach the Organiser in writing <u>biuro@rajdmalopolski.pl</u>) before the start of the Administrative Checks.

#### 5. Insurance Cover

#### 5.1. Insurance coverage for the organiser

#### 5.1.1 Organiser's liability insurance

The Organiser has concluded an insurance contract with Organiser's liability insurance covering damage caused to a third party during the competition. The insurance cover will come into effect from the start of the rally and will cease at the end of the rally or at the moment of permanent retirement or disqualification. Cars having retired and restarted shall not be considered to have permanently retired. Crews participating in the Shakedown will be insured for its duration under the same policy.

#### 5.1.2 Damage caused to the third parties.

A part of the insurance contract is coverage for damages caused to a third party. However, damages caused by drivers among themselves are not covered by this contract.

#### 5.1.3 Car third parties' liability insurance

All crews at Administrative Checks must hand in a valid motor third party liability insurance policy International Green Card for their car. Without this card, the crew won't be permitted to start.

#### 5.2 Insurance coverage for competitors and crews

All the drivers and co-drivers are obliged to arrange their own accident insurance. The proof should be documented on request at Administrative Checks. The insurance of foreign crews have to cover the costs of possible medical treatment in Poland and their repatriation, if necessary, in the event of an accident. By the fact of signing the entry form, the competitors and/or driver/co-driver relinquish any claims to compensations of any kind which might result due to incidents during the Rally. The relinquishment is applied to FIA, ASN and the Organiser, officials and other competitors and/or driver/co-driver.



## 5.3 Damage reporting

The competitor or his representative are obliged to notify the Organiser in writing about any damage caused on the track by their car as quickly as possible and within 24 hours. Violation of this duty stands for summoning the competitor and involved crew to a disciplinary committee. He must explain the circumstances under which the accident occurred. Likewise, he must mention the names and addresses of any witnesses.

#### 5.4 Insurance coverage exclusions

Service and auxiliary vehicles, cars dedicated to Reconnaissance rides and other vehicles with special plates issued by the Organiser are not covered by the provided rally insurance (with the exception of insured Organiser's cars) and those are always going on their own responsibility.

#### 6. Advertising and Identification

See Appendix 4 of these SR "Decals and positioning of supplementary advertising".

Advertising must comply with Polish law. No political, religious or abusive advertising. Advertising for alcoholic beverages and tobacco are forbidden. These laws apply to competing cars, service cars, team equipment and clothes.

The organiser will provide each crew with the number identification (67x17cm), which must be affixed to their car in the stated positions prior to scrutineering. Each panel shall be placed horizontally at the leading edge of each front door, with the number at the front. The top of the plate shall be between 7 cm and 10 cm below the lower limit of the window. It is not allowed to cut the panel.

#### 6.2 Optional organiser's advertising

The organizer provides additional advertising on cars with compatible locations and dimensions with Annex No. 4 to these regulations, in compliance with the requirements of point 8.3.1, 8.3.2 of the RSMP 2024 Regulations. The content of the additional advertising of the rally will be published in a bulletin on the rally website in accordance with Art. 8.3 of the RSMP 2024 Regulations.

**6.3** Inspection of the placement of starting numbers, rally boards and additional advertising of the organizer will be carried out during Scrutineering. Lack or placement of placards referred to in Art. 6.2 of these supplementary regulations, contrary to Appendix No. 4, will be treated as an application without additional advertising by the organizer, which, in accordance with Art. 4.4.2 of these supplementary regulations corresponds to the increased entry fee.

**6.4** The Organiser have the exclusive rights to run every kind of promotional, advertising and commercial activities in the Rally HQ, Start and Finish areas, Scrutineering places, Service Park, Parc Fermé and along the entire route of the rally. Each company interested in running any promotional, advertising or commercial activities at the rally should contact the Organiser with suitable advance and sign the agreement.

#### 6.5 Start-Finish

During Ceremonial Start and Finish of the rally, the crews (driver and co-driver) are not allowed to be accompanied at the podium by members of their team or any other people. Displaying advertising elements such as flags, banners, umbrellas etc., as well as distributing advertising materials is forbidden.

#### 6.6 Service Park

Advertising may be placed in the Service Park, subject to the conditions set out in Art. 13.10 of the RSMP Regulations. Placing advertisements by the competitor outside the boundaries of the allocated service area, in accordance with Art. 4.4.6 of these supplementary regulations may only take place after consultation with the organizer and written consent. Cases of non-compliance with the abovementioned cases identified by the Service Park Manager. requirements will be subject to a fine of up to 500% of the entry fee paid for the registered crew.

#### 6.7. Starting numbers

The starting numbers provided by the Organizer must be placed on both sides of the car on the front doors, two rear side windows and on the rear window, in accordance with Appendix 4 to these Supplementary Regulations throughout the duration of the rally. If at any time during the rally it is found that the starting number or rally plate is missing, this



will result in a financial penalty at the discretion of the stewards. The lack of two starting numbers or a rally plate may result in disqualification by decision of the Stewards.

#### 7. Tyres

#### 7.1 Regulations regarding tyres which may be used during the Rally.

All tyres used by the crew during the Rally must comply with Art. 14 of the 2024 RSMP Sporting Regulations. During the Rally, all used tires will be checked and marked in accordance with the above-mentioned regulations. Tyres that do not have the E approval mark must comply with the above-mentioned regulations.

**7.2** The tire size must be permissible in accordance with Art. 14.5 of the RSMP Regulations, and the width cannot be greater than the maximum specified by the rim manufacturer. The inside of the tire (the space between the wheel rim and the inner part of the tire) can only be filled with air.

#### 7.3 Tyres for use on reconnaissance

All tires used during reconnaissance must bear the E approval mark.

#### 7.4 Tires heating zones

Pursuant to Art. 14.5 of the RSMP 2024 Regulations, the organizer informs that before SS 1/3 - Barwałd and SS 6/9/11 – Stryszów, a tire heating zoneS will be organized on the principles described in Art. 44.4 of the Sports Regulations. FIA

#### 8. Fuel

All type of fuel must follow Appendix J Art. 252.9. (RRSR Art. 62).

### 8.1 Refuelling

**8.1.1** Refueling may only take place in the refueling zones indicated in the Road Book. During refueling, a maximum of 2 people per crew are allowed in the refueling zone. The full responsibility for refuelling is on the competitors' site. During refueling, all personnel involved in the refueling operation must wear clothing that provides adequate protection against fire and consists of a minimum of long trousers, long-sleeved shirts, full boots, gloves and balaclava. It is recommended that each team, when carrying out the refuelling procedure, have to be equipped with a powder extinguisher with a minimum mass of the extinguishing agent of 2 kg. Engines must be switched off throughout the refuelling operation. Additionally, the crew must be outside the car when refuelling.

**8.1.2** Environmental Mat in a Refuelling Zone (RA).



The Organiser, will protect the ground with an Environmental Mat.

#### 9. Reconnaissance of Special Stages

**9.1** On June 5, 2024 – Wednesday, at 19:00 – 22:00 (alternative) and 06/06/2024 – Thursday, at 06:00 - 08:00, at the Rally Office, for competitors registered in the rally, necessary reconnaissance documents will be distributed. The crews will receive, among others: a road book, a recce card, and plates with numbers for the recce car.

**9.2** Reconnaissancewill take place on June 6, 2024. – Thursday, in accordance with the schedule constituting Appendix No. 2 to these supplementary regulations.

**9.2.1** Reconnaissance of the SS 5 Wadowice can be carried out on June 6-7, 2024. - Thursday Friday, at any time, only on foot.

#### 9.3. Specific regulations

**9.3.1.** Crews registered for the rally are entitled to 2 runs of each special stage (does not apply to SS 5). During each run on a special stage, only the crew may stay in the car. Crews may not move on special stages in the opposite direction to the designated one ("against the flow"), considering the conditions set out in Art. 11 of the RSMP 2024 Regulations, except for the cases specified in the Road Book (or Recce Book - if such a document will be issued) while maintaining an extreme caution.

The organizer of Valvoline Rally Małopolski, by June 3, 2024 (Monday), will prepare and make available on the website www.rajdmalopolski.pl onboard videos of all Special Stages.

The organizer will monitor the course of reconnaissance in terms of compliance with both road traffic regulations and other regulations, with Art. 35 of the FIA Sporting Regulations and these supplementary regulations. At the request of marked representatives of the Organizer and the Police, competitors must present appropriate documents and follow the orders and instructions issued by them. Inspections will also be carried out before the period intended for Reconnaissance. Each team member (competitor, drivers and support team) taking part or intending to take part in the Rally, whose presence on the SS beyond the date set for reconnaissance, will be considered as carrying out unauthorized reconnaissance (does not apply to SS 5).

**9.3.2** During reconnaissance, Rally crews must stop at the start and finish of each Special tage (does not apply to SS 5) to obtain an entry time in the reconnaissance card. Crews can only enter the special stage via the start line and exit via the finish line. All cases of violation of the above rules will be reported to the Stewards.

**9.3.3** The Reconnaissance Card must be returned IN Rally Office 06.06.2024r – Thursday, during its opening hours.



**9.3.4** Reconnaissance Cars must have the insurance policy according to Polish Traffic Law Act and no liability can be transferred to the Organiser.

**9.3.5** All crews must perform activities related Reconnaissance in production cars that meet the requirements specified in Art. 35 of the FIA Sporting Regulations, considering Art. 11.7 of the RSMP Regulations for 2024.

**9.3.6** Number plates for the Reconnaissance car should be attached in the upper right (co-driver's side) corners on the front and rear windows of the Reconnaissance car. They must be clearly visible throughout the entire Reconnaissance.

**9.3.7** During reconnaissance, all national traffic regulation must be followed, including but not limited to the speed limits.

- 50 km/h in the built-up area (if the sign does not show otherwise),
- 90 km/h outside the built-up area (if the sign does not show otherwise).

Using the radar detectors is forbidden.

**9.3.8** Each Reconnaissance car must be equipped with a GPS speed control device. GPS devices will be distributed in accordance with point 10.2 of these regulations.

The GPS device will be distributed after paying a fee for its use (PLN 100 / EUR 25) and a refundable deposit (PLN 200 / EUR 50). GPS devices for speed control during Reconnaissance must be installed in accordance with the instructions in Appendix No. 6 to these supplementary regulations. If the crew needs assistance with this activity, the GPS service will provide it in the Service Park immediately before starting to Reconnaissance. The GPS system used during Reconnaissance is an official speed measurement and the data recorded by it will be analyzed by officials. The evaluation of GPS data is the responsibility of the Rally Director. Reconnaissance cars not equipped with functional GPS speed control devices will be reported to the stewards. The installation of the device and its correct connection to the power supply may be checked at all controll points located on special stages during the Reconnaissance of the rally route and along the entire rally route by marked representatives of the Organizer. If it is found that the GPS device is not functioning due to improper installation or crew interference in its operation, the Stewards will be notified of this fact and may decide to impose a penalty. Each competitor is financially responsible for the GPS device installed in his car. If the device is damaged due to the competitor's fault during Reconnaissance with the rally route, he is obliged to compensate the damage before the first meeting of the Stewards.

GPS devices used during reconnaissance must be returned to the Rally Office on June 6, 2024 - Thursday, during the opening hours of the Rally Office. If the GPS device is damaged due to the competitor's fault, he will be obliged to compensate the damage before the first meeting of the Stewards.



**9.3.9** Any crew that do the Reconnaissance in violation of the Art. 9.3 of these supplementary regulations will be punished with a penalty according to Art. 10.1.1 and art. 11.3 and art. 11.6 of the RSMP Regulations, regardless of administrative penalties.

#### 9.4 Location of speed control systems

During the Reconnaissance, police patrols with speed measuring devices will be deployed on individual special stages and the access route, cooperating with the SS Commanders supervising the number of runs and correctness of Reconnaissance.

**9.5** Each competitor registered for the rally has the right to use the so-called a Reconnaissance car, which may contain no more than 2 people representing the competitor. A Reconnaissance car, marked with special stickers (in accordance with Appendix No. 5 to these supplementary regulations), with numbers corresponding to the number of the competitor it represents, will be able to enter the SS route 80-65 minutes before the start time of the first crew for this SS. This car must drive on the SS in accordance with road traffic regulations, in the direction of the SS. If the safety car overtakes the safety car, it must absolutely leave the SS and cannot return to it. Fracture of the above-mentioned regulations will result in consequences for the represented competitor, imposed by the Stewards.

9.6 The right to use a Reconnaissance car is not available on SS 5.

Each competitor must be present at Administrative Checks at the time designated for him, which will be announced in a Bulletin on the Digital Notice Board on the rally website www.rajdmalopolski.pl on 31.05.2024 (Friday).

### 10.3 Documents to be presented at the Rally Office

According to Art. 4.2.7 Administrative Checks will be organised remotely when entry is received. The above procedure does not exempt from the obligation to appear for Administrative Checks at the scheduled time. Each Competitor may nominate in advance one authorized representative to complete Administrative Checks and collect the materials and documents.



To keep the time required for the administrative checks to the necessary minimum, make sure to bring and present the following documents:

- Duly completed and signed original entry form,
- Competitors' licence (does not apply to licenses issued by PZM),)
- Driver's and co-driver's competition licences
- Driver's and co-driver's valid driving licences

• If the start is to take place in a car lent or rented to participate in the rally, the competitor signs a statement that he has the consent of the owner to participate in the above-mentioned competition. with this car.

Should also be prepared to present an original of all other required documents mentioned in Art. 4.2.7.

### 10.4 Organizer's documents

After Administrative Checks competitor will receive Scrutineering Card to present on the Scrutineering.

## 11. Scrutineering, Sealing and Marking

## 11.1 Location

Cars may be presented at scrutineering by a representative of the team. See programme (SR Art. 3), at the designated time, which will be published in a Bulletin on the Digital Notice Board on the rally website – <u>www.rajdmalopolski.pl</u>. on 31 May 2024 (Friday).

### 11.3. Scrutineering, mandatory documents:

- Scrutineering card (obtained at Administrative Checks),
- Driver's and Co-driver's safety equipment card (downloaded from the rally website, legibly filled in),
- Car's technical passport (FIA or ASN),
- Cars' complete certified FIA homologation form,
- Vehicle registration papers,
- ASN Safety cage certificate, when it's applicable,
- ASN Catalytic converter when it's applicable.



**11.3.1** A valid entry in the registration certificate confirming that the car has passed a technical inspection is considered proof that the car meets all the requirements of the Road Traffic Act, including safety and environmental protection regulations, and is approved for road traffic in the territory of Poland.

**11.3.2** During Scrutineering, all crew personal safety equipment must be presented for inspection in accordance with Art. 12.1, 12.1.1 and 12.1.2 of the RSMP 2024 Regulations.

### **11.4. Other requirements**

**11.4.1** Each car must be brought to the Scrutineering, at the time designated for it, which will be published in a Bulletin on the Digiteal Notice Board on the rally website - www.rajdmalopolski.pl on May 31, 2024. (Friday). For any delay found at the entry control point for the Scrutineering, in relation to the time schedule, the case will be subject to a fine of PLN 300. If the delay exceeds 30 minutes, the competitor will be reported to the Stewards.

**11.4.2** In particularly justified cases, at the competitor's request, the Organizer may set a new time for the Scrutineering beyond the designated time limit.

**11.4.3** Every competitor which wants to use a camera during a rally, this camera must be presented installed in a rally car at the time of Scrutineering. Scrutineers will check if a camera is installed in compliance with Appendix No 6 to RSMP 2024 Regulations.

**11.4.4** Use of tinted windows is authorized in accordance with Article 253.11 "Windows/nets" of Appendix J of the FIA International Sporting Code.

**11.5** Scrutineering for cars that failed to complete Leg 1 (section 1, 2 and 3) and want to start to Leg 2 (section 4, 5, 6 and 7) will be held on Saturday 08.06.2024 at 7:00. Cars must be entered into the Parc Fermé until above mentioned time.

#### **12. Other procedures and regulations**

12.1.1 Ceremonial start procedures and order

Competitors are obliged to participate in the Start Ceremony in overalls and sports shoes, together with the car in which they will start in the rally. Failure to fulfill the above obligation will result in a financial penalty of PLN 500.

To ensure the smooth conduct of the Honorary Start, a pre-start park will be organized for all crews taking part in the Rally. Rally cars must be entered into the pre-start park only by the crews. ### 12.4 Starting system to the Special Stage

**12.4.1** At the start of each special stage (does not apply to SS 5 Wadowice) there will be an electronic starting device equipped with a two-digit display and two green lights. It will be connected to a photocell which task will be to detect



possible false starts. The photocell will be located approximately 50 cm behind the starting line. The display of the starting device will be located so that it is clearly visible to the crew in the car standing on the starting line. The car and crew line up at the starting line, and the starting device continuously counts down and indicates the seconds remaining until the green light turns on. The display shows in sequence: 30, 15, 10, 5, 4, 3, 2, 1, green light. The green light stays on for 20 seconds. The crew should start within this time, otherwise Art. 48.4.3 of the Sporting Regulations of Regional Rallies applies.

12.4.2 At the start of the special stage SS 5 Wadowice there will be a signal equipped with red and green lights. When the green light turns on, it will mean the start of the special stage. The green light stays on for 5 seconds. At this time, the crew should start. Crossing of the line marked by the photocell means the start of time measurement on the SS. Entering the Special Stage when the red light is on will result in a penalty being imposed (in accordance with Article 48.6 of the FIA Sporting Regulations)

12.4.3 Time measurement on SS will be given with the precision of 1/10 second.

12.5 Permitted early check-in:

• TC 5A – Parc Fermé - In

• TC 13A – Parc Fermé - In

#### 12.6 Re-start after retirement

#### 12.6.1 Re-start Leg 2

A crew which has failed to complete a section may be assumed to re-start the rally from the start of the next section following the overnight regroup unless they confirm otherwise with the Clerk of the Course by completing of the form located in the rear of the road book ("final retirement") and lodging it with the Organiser as soon as possible and, if feasible, before the publication of the re-start list. The car must report to the overnight Parc Fermé prior to the next section following the overnight regroup, no later than 1 hour before the scheduled start of the 1st car. Re-scrutineering will be 1 hour before the start of the 1st driver.

### 12.6.2 Parc Fermé for re-starting cars

There will be no dedicated Parc Fermé for retired re-starting cars. These will use the same Parc Fermé as for the rest of the event.

#### 12.7. Service Park

12.7.1. Only one Service Park will be organized, located in Wadowice along the streets Nadbrzeżna I - Sienkiewicza, (34-100 Wadowice)

#### 12.7.2 Access

Service Park can be entered only with competition cars, Service cars (SERVICE plates) and Auxiliary vehicles (AUXILIARY plates). All plates must be affixed to the upper side of the windscreen on the right (passenger) side. Removal of the sticker and use one sticker on different cars is prohibited until the end of the rally. All cars must be parked inside a service area allocated for a competitor.

Reconnaissance cars and VIP vehicles are not allowed to enter the Service Park.

Entrance from Thursday 06 June 2024, between 14:00 - 21:00, departure Saturday 8 June 2024 till 20:30.

**12.7.3** The competitor is obliged to service only within the allocated service area in the Service Park. These regulations will be controlled by the Service Park Coordinator. Any infringement will result in charging a double fee for additional service area: 50 PLN per 1 m<sup>2</sup> – for private entrants and 70 PLN per 1 m<sup>2</sup> – for legal entrants.

**12.7.4** All competitors are obliged to use a liquid-proof tarp (size 4x6 m; thickness min. 0,5 mm) on their service area (under serviced cars). Any damages to the surface of the Service Park must be avoided. Each Competitor is responsible for the damages to the allocated service area. Teams are responsible for the removal of their waste and sewage.

**12.7.5** In the Service Park on June 7, 2024. (Friday) from 12:00 traffic is to be in one direction, snaking is forbidden. A speed limit of 30 km/h is obligated. Failure to comply with the above-mentioned restrictions will result in a penalty being imposed on the competitor in accordance with Article 10.1.2 of the RSMP 2024 Regulations.

**12.7.6** The Service Park will not be supervised by the organizer. The organizer is not responsible for any damage or theft of equipment during the rally.

12.7.7 It is strictly forbidden to use your own charcoal grills or open fires in the service park. Competitors are obliged to keep order at their position. Smoking cigaretes will only be allowed in designated areas.

#### 12.7.8 Flexi-servis

The organizer does not foresee Flexi-service.

### 12.8. System monitorowania GPS

**12.8.1** GPS safety tracking system unit will be installed by the GPS service team just before Scrutineering. Before Scrutineering, all cars must have antenna and system console installed according to instruction. These parts can be obtained from GPS service team.



**12.8.2** PZM-GPS safety tracking system is used to check if crews drive according to Road Book and it is also an official speed checking device used during the rally. If system indicate a fact of speeding, competitor will be penalized according to Art. 10.1.1 and 10.1.2 RSMP 2024 Regulations.

**12.8.3** Any crew without a system installed in a car will not be able to start in rally and/or Shakedown stage. The place and time of installation/disassembly of GPS devices are specified in Annex 7 to these regulations. A competitor who did not finish the rally is obliged to return the GPS device to the PZM GPS system coordinator until the final classification of the rally is published. Failure to fulfill this obligation will result in a financial penalty of PLN 500.

**12.8.4** PZM-GPS safety tracking system will be removed in the final Parc Fermé, after TC 13A. In case a team withdraws from the Rally, PZM-GPS safety tracking system unit should be returned to the PZM-GPS Coordinator before a provisional results publication time. Failure to comply with this rule will be penalized with a financial penalty 500 PLN.

**12.8.5** Each crew is materially responsible for PZM-GPS safety tracking system installed in their car during the Rally. In case of damage PZM-GPS safety tracking system during the rally, the competitor is obligated to compensate the damage before the last Stewards Meeting. Failure to comply with this rule will be penalized with a financial penalty imposed.

**12.8.6** In case of damage or PZM-GPS safety tracking system malfunction, device will be replaced at the time set by the Organiser. Each replacement of the PZM-GPS device will be reported to the CoC and he will decide to cancel time penalties caused by device replacement.

**12.9** Shakedown (extra paid)

12.9.1 The Organiser provides a Shakedown stage on07 June 2024 (Friday), from 08:00 till 12:00. Competitor should declare in the entry form his intention to participate in the Shakedown. The cost of participation in the Shakedown is 600 PLN. The Organiser has the right to call Shakedown off if less than 15 applications are received.

**12.9.2** Only cars that have passed the Scrutineering and have mounted fully operational the PZM-GPS safety tracking system can participate in the Shakedown (after paying the fee). Competition numbers and advertising stickers must be affixed to the cars.

**12.9.3** Only first driver can drive the car during Shakedown. Team engineers or other person nominated by competitor / driver can be on board of the car during Shakedown if he/she signs a special declaration that he/she participate in shakedown on his/her own risk – responsibility disclaimer. Disclaimer form will be available at the Rally Office and at the Shakedown start. It is compulsory to wear the safety equipment of driver and co-driver as for normal Special Stage. On the Shakedown stage car must stop at the start and stop point to present a Timecard and obtain a permission to drive.





**12.9.4** For the test section, the Organizer has planned two additional Service Parks, which will be located:

Stryszawa – Ośrodek Dziedzictwa Kulturowego, Stryszawa 263 34-205 Stryszawa

and:

Stryszawa LKS Jałowiec Stryszawa 278E 34-205 Stryszawa

**12.9.5** It is forbidden, without the written approval of the Organizer, to conduct private tests in the Wadowice and Suski counties from May 8, 2024. until June 8, 2024, under risk of not being allowed to take part in the rally. Approval will be given to each private test stage organizer upon submission of the appropriate permits.

#### 12.10 Rally finish ceremony procedure

The sports part of the Rally will finish at TC-13A (Park Ferme – In).

Immediately after the end of the Rally (PKC 13A), the cars designated by the Stewards will be taken for a detailed scrutineering. The crews concerned are obliged to follow the instructions of the organizer. Competitors are obliged to provide at least one entry representative and an appropriate number of mechanics during Scrutineering 2.

#### 15.2 Protest deposit

**15.2.1** All protests must be submitted in accordance with the provisions of the International Sporting Code (Article 13 et seq.).

**15.2.2** All protests must be submitted in writing to the Rally Office along with a deposit of 100% of the entry fee, which will not be refunded if the protest is not recognized.

15.2.3 If the protest requires disassembly and reassembly of car parts or assemblies and inspection of the type of fuel used, the person making the protest must pay a deposit, the amount of which will be determined by the Stewards at the request of the Technical Delegate. If the protest is not recognized and the costs incurred in connection with its consideration exceed the value of the deposit paid, the difference will be paid by the protester. However, if the value of the deposit paid exceeds the costs associated with examining the protest, the difference will be returned to the protester. If the protest is upheld, all costs associated with it will be transferred to the competitor against whom it was lodged.

#### 15.3 Cancellation deposit

Deposit when announcing an appeal against the Stewards' decision: PLN 3,000. All protests and/or appeals must be submitted in accordance with the provisions of Art. 13 and 15 of the FIA MKS and, where appropriate, the application of the FIA Judicial and Disciplinary Jurisdictions.





#### Appendix No.6 – User manual for the GPS device used to monitor the Reconnaissance of the rally

#### Description:

The GPS system is designed to monitor the Reconnaissance. It is installed in the car indicated by the competitor. The device records and continuously transmits data from the vehicle. The route history is only processed during reconnaissance. The staff is authorized to inspect the device at any time during Reconnaissance.

#### Installation:

The device must be mounted on the inside of the vehicle's rear window. Installation involves mounting the device in a safe and visible place. The best solution is to mount the device to the rear seat using cable ties (see example below). If the device has an antenna, mount the antenna in the middle of the roof (the antenna has a magnet). Any interference with the device is prohibited: disassembling, disassembling, etc.

#### Device power supply:

The device has its own power supply.

#### Competitor's responsibilities:

1. Install the device and secure it so that it does not pose a danger to the crew.

2. For the duration of the Reconnaissance, from the time the device is issued until it is returned, the device must be in the car.

3. After completing the Reconnaissance, return the intact (undamaged) device to the rally office. The following will be considered as damage to the device:

- noticeable damage to the device housing,
- · violation of the seals protecting the device,
- antenna damage.

#### Appendix No. 7 – Safety Tracking System

- 1. The PZM-GPS safety tracking system unit is installed by the PZM-GPS service team.
- The PZM-GPS safety tracking system unit is owned by PZM and will be removed after the end of the Rally.
- 3. You will be given a receipt that will authorize you to collect the documents from the Rally's Office.
- 4. In case a team withdraws from the Rally the PZM-GPS safety tracking system unit should be returned to the PZM-GPS servicemen who will be available at the Service Park or it should be delivered to the Rally's Office.

#### Mode of operation PZM-GPS safety tracking system

The PZM-GPS safety tracking system installed in your vehicle during the Rally sends a signal to the Rally Command Centre (RCC). The system is working only on Special Stages and is activated automatically, so it doesn't need any operation before start and after finish the SS. In case of stopping the car on the SS system is sending the warningsignal to the car unit. The lamps in manipulator panel (Green and Red) start blinking. That means that operator of RCC see the car standing on the SS and expect to have the information from the crew. Within 1 minute from stopping over the Special Stage the driver or the pilot should press the proper button to clarify the situation. PRESSING the GREEN BUTTON means that there is NO NEED to send the emergency service (OK). To avoid accidental activation, the GREEN BUTTON must be depressed for 2 seconds. Correctly pressing the green button will be confirmed by short blink of green lamp in the button and acoustic signal (two short loud beeps). NOT PRESSING the GREEN BUTTON within 1 minute after stop on the SS means the necessity of an assistance and it will initiate the intervention of the emergency service. In case of emergency, when the crew would need any help form RCC the RED BUTTON should be pressed. Depressing the RED BUTTON means the emergency and the crew need help for themselves or for somebody else (for example, if they noticed any dangerous situation over the SS). To avoid accidental activation, the RED button must be depressed for 2 seconds. Correctly pressing the red button will be confirmed by short blink of red lamp in the button and acoustic signal (two short loud beeps) Within few second after depressing any button, the lamp inside them will light constantly. That means the information from the car is received by RCC and the status of the car is known by the RCC operator. In case of any needs the operator of Rally Control Centre can send to the Rally crew a reminding signal (series of short beeps) and blinking the YELLOW LAMP. The reminding signal can be cancelled by pressing any proper button on manipulation panel.
